# CHAIRMAN'S INTRODUCTION

It has been a busy start to 2017 and there is a lot to update you on.

The main points are:

Just before Christmas, with very late notice from Councillors, we put in our submission to the Local Government Boundary Commission regarding the Warding pattern for the London Borough of Croydon on behalf of MORA (see Page 8). We are told this is Phase 1 of the consultation and further opportunities will be offered to respond with our views.

In February, the 20mph consultation for areas 3, 4 and 5 closed. Croydon Council removed the two-stage process used for areas 1 and 2, and decided to consult on all the remaining areas together without offering residents the opportunity to vote on the proposal. The council deemed the simple YES/NO vote was too confusing and therefore residents were only able to raise objections. The Traffic Management Advisory Committee is scheduled to consider the objection reports on 9 May 2017. We await the outcome from this meeting. But with many of the 20mph signs already installed, this seems to be a forgone conclusion.

Derek, our planning specialist has been hard at work objecting to numerous over development applications in Orchard Avenue, Orchard Way and The Glade. Some properties have already been demolished to make way for flats, all of which are out of the intensification zone set out in the Croydon Local Plan. It seems that current administration is determined to destroy Shirley by disregarding planning policies. We continually attend council planning committee meetings to object to property developers plans with valid objections regarding Public Transport Accessibility Levels (PTAL), residential housing density and changing the character of the local area. Our objections are, ignored without debate by the council planning committee, and in some instances not even minuted. Despite this, we will continue to raise our objections and concerns in the hope that they will be considered and accepted. All Shirley residents can attend the council planning meetings, details can be found on our website – we'd welcome your support.

London Borough of Croydon submitted the proposed submissions for Croydon Local

Plan (CLP2) to the Secretary of State in February. The Secretary of State has appointed an inspector from the Planning Inspectorate to carry out an independent examination of the Croydon Local Plan. The inspector's task is to consider the soundness of the plan, based on the criteria set out in the National Planning Policy Framework (NPPF). Public hearing sessions dates are now advertised on the council website, please see Page 6 for more details. MORA will be attending these to make sure the objections we put forward have been considered.

I am looking forward to seeing many of you at MORA's 93rd **AGM, to be held on Tuesday 25 April 2017** at Edenham High School. Last year's AGM had a great turn out and we are looking forward to presenting more detailed updates to you.

In the meantime, I wish you a good Easter break.

# NINETY-FOUR YEARS OF MORA

We are now approaching the ninety-fifth\* year of our Association's inception, set up in 1922 by a group of people whose sole aim was to safeguard the interests of the area and its residents. Very different from today the area was significantly larger, being the old East Ward of Croydon Borough Council, which stretched a little beyond East Croydon Station, north and south of Upper Addiscombe Road and along Wickham Road. The group became 'The East Ward Electors' Association' (EWEA).

The first ten to fifteen years saw rapid growth in local housing development and consequently the population and all that went with it. As a result the Association became more and more involved with anything from pressing hard for better postal facilities in the newly developed Glade area, to local public transport problems and adequate education facilities for the area's children. Also, a committee meeting at the beginning of 1933 unanimously agreed that the proceeds from the forthcoming Charity Dance should be devoted to the supply of milk to 'necessitous Croydon school children'. A sign of the times indeed! This was only one of the many fund-raising events for charity.

The committee minutes of January 1934 reveal Croydon's preparations for a possible outbreak of war, with The Chief Officer of Croydon Fire Brigade giving a talk on anti-air raid precautions and fire protection.

Interestingly, even at that early stage, they had already carried out experiments in Croydon for dealing with gas attacks.

1937 saw the infamous outbreak of typhoid in the Croydon area with 41 cases, in January 1938, in the East Ward alone. Water from the Addington (Shirley Hills) well, which supplemented that from the Stroud Green (Shirley Road) well, was contaminated and proved to be the source. Croydon Council came severely under fire from the Association for not giving proper warning after the first outbreak.

Just before the outbreak of WW2 the Association put every effort possible into their 'Save Shirley Park' campaign, the area of the original 'Shirley House' country estate of John Maberley, which subsequently became Shirley Park Hotel and is now Trinity School. Their aim was to persuade Croydon Corporation to purchase the

land, which included the golf club, to preserve it as a green space for the benefit of local people. I have been unable to find the reason for their action and can only assume that the land was up for development. Their efforts proved successful as, in June 1939, the Corporation agreed to the estate's purchase.

In October 1939, just a few weeks after the outbreak of WW2, the Association's Executive Committee met to consider the way forward in respect of their activities. Despite the fact that membership could very well drop due to the current situation, they unanimously decided to continue but in the form of an 'Emergency' committee. They even decided to carry on with certain social and fundraising activities. The famous wartime phrase 'Keep Calm and Carry On' immediately comes to mind!

Committee meetings continued throughout the war years, albeit intermittently. Attention remained in respect of the well-being of local residents particularly, with the progression of the wartime conditions, the problem of housing and the plight of those locally who had suffered through enemy bombing. To the best of their ability the Association also raised and donated to 'comfort funds' for the forces as well as other current causes.

Peacetime saw the Association intact, gradually returning to normality and resuming its ordinary activities as before. That was, until the 1970s,



when revision of the Ward boundaries took place and, as a result, the demise of the old East Ward. Now only a portion of the old Ward the EWEA, at the 1977 Annual General Meeting, resolved that the Association would hence be known as Monks Orchard Residents' Association (MORA).

MORA continues to do its very best where it can for local residents, admittedly with some failures but also with some successes, along the way. Probably the most notable of the latter was, in 1990/92, the fight against the might of Tesco who wanted to build a store at the top of Orchard Avenue. Several hundred residents attended the public meeting at the Shirley Parish Hall. Too many for inside, around a couple of hundred gathered outside to add their protests. Committee member, Mr. Horton had to keep running

from the proceedings to outside the hall to update the crowd who couldn't get in! More recently the 'Shirley Triangle', lying between Shirley Avenue, Valley Walk and Shirley Road, has now been deemed, after a long struggle, a Nature Conservation Area.

Being the current 'keeper' of the Association's archives, I've had the opportunity to read about the Association's past, which involved just ordinary local people who cared about where they lived and those who lived here. It's ability to have continued for all this time is something to be proud of.

Decisions by authorities don't always go our way, despite what we believe are valid arguments. However, our presence can, to some extent, hold them to account.

'Until the 1940s the AGM was in September [the first AGM September 1923 at the end of the Association's first year] but, probably due to wartime conditions, was then moved forward by about 6 months to the following March/April around which time the date for the AGM has remained.





# CALLS FOR NHS TO CURB INAPPROPRIATE ANTIBIOTIC PRESCRIBING.

**A**s a member of the Hartland Way Surgery PPG, I have been asked to provide an article in our MORA magazine on the reasons to curb inappropriate antibiotic prescribing. This is an extract from an article published by the National Institute for Clinical Excellence (NICE). After all, we should be responsible for our own health and as the population ages and life expectancy increases, we may be facing a serious medical dilemma if there are not adequate antibiotics that can treat infections simply due to overuse leading to resistance.

Healthcare professionals should encourage sensible use of antibiotics and cut back on unnecessary prescribing of the drugs to help tackle the rise in antibiotic resistance, says NICE. Patients should feel confident to accept non-pharmacological measures or best still demand if in their case that would be an option, if the healthcare practitioner does not.



Antibiotics are a vital tool for modern medicine and not just for the treatment of infections, such as pneumonia, meningitis and tuberculosis, but also for preventing

infections from occurring during surgical procedures and cancer treatment.

However, the more antibiotics are used the less effective they become. This is because overuse gives resistant bacteria a greater chance to survive and spread.

The problem of antibiotic resistance is compounded by the fact that the discovery of new antibiotics is at an all-time low.

Despite considerable guidance that prescribing rates of antibiotics should be reduced, 9 out of 10 GPs say that they feel pressured to prescribe antibiotics, and 97 per cent of patients who ask for antibiotics are prescribed them.

The first NICE guideline to address this issue recommends that GPs, nurses, pharmacists and dentists promote and monitor the sensible use of antimicrobials – a group of medicines that includes antibiotics.

If successfully implemented, NICE's guidance could help to reduce inappropriate antibiotic prescribing by 22 per cent – accounting for 10 million prescriptions.

The guideline recommends setting up multidisciplinary antimicrobial stewardship teams working across all care settings. These teams should be able to review prescribing and resistance data frequently and feed this information back to prescribers.

They should also be able to work

with prescribers to understand the reasons for very high, increasing or very low volumes of antimicrobial prescribing as well as provide feedback and assistance to those who prescribe antimicrobials outside of local guidelines where this is not justified.

Professor Mark Baker, Director of the Centre for Clinical Practice at NICE, said: "Antibiotics are prescribed in circumstances when they are unlikely to do the patient much good. Knowledge amongst GPs is well established that many patients with early or benign infections do not require and will not benefit from antibiotics. The vast majority of GPs will tell patients that.

"I don't think there is a lot of bad practice in general practice but it is clear that the reduction in antibiotic prescribing that we expected to see when our 2007 guideline on upper respiratory tract infections was published, has not happened.

"The rise in inappropriate prescribing comes in the face of successive attempts by NICE and by government to reduce it that simply haven't worked. Some of it is about the pressure put on GPs. Despite that pressure, prescribing an antibiotic when you know it's unlikely to do the patient much good is not good practice.

"It's not just prescribers who should be questioned about their attitudes and beliefs about antibiotics", added Professor

Baker. "It's often patients themselves who, because they don't understand that their condition will clear up by itself, or that perhaps antimicrobials aren't effective in treating it, may put pressure on their doctor to prescribe an antibiotic when it is not indicated and they

are unlikely to benefit from it. "The guideline therefore recommends that prescribers take time to discuss with patients the likely nature of their condition, the benefits and harms of immediate antimicrobial prescribing,

alternative options such as watchful waiting and/or delayed prescribing and why prescribing an antimicrobial may not be the best option for them – for example, if they have a self-limiting respiratory tract infection."

## TEA AND CAKE IN 1916: A SHIRLEY NEIGHBOURHOOD CARE OUTING

As a special twist on our tea and cake outing this month we went to the 'Remembering 1916' exhibition at Whitgift School, South Croydon. This exhibition opened last March and had such good reviews that the closing date has been extended to April this year. Our troop of eager volunteers and clients went one Friday afternoon in January and were very lucky to have a guide that walked us through the exhibition. We stopped halfway to take

afternoon tea in the Edwardian café and then continued after a sit down and refreshments.

The exhibition is comprehensive for that year of the Great War – 1916. So many events took place such as the battles of the Somme and Jutland. The exhibition displays many unique items which have all been lent to the school by private collectors and veterans families such as British, French and German uniforms and equipment.

Scenes of military and home life have been constructed to give a realistic feel of the times. A worthwhile trip enjoyed by all.

This site is dedicated to the examination of the Croydon Local Plan and will be updated regularly throughout the process.

On 3 February 2017, the London Borough of Croydon submitted the **Croydon Local Plan: Strategic Policies – Partial Review (Proposed Submission)** and the **Croydon Local Plan: Detailed Policies and Proposals (Proposed Submission)** to the Secretary of State for independent examination.

The appointed planning inspector, Paul Clark MA, MRTPI, MCMl will confirm as the examination progresses

the matters and issues of the Croydon Local Plans for discussion at the hearing sessions, if not resolved in writing before then.

He will group his concerns and the representation made by others into themes for discussion at the hearing sessions. A further briefing note will be sent nearer the time to those the inspector invites to participate in any hearing session.

The independent programme officer who is managing the examination on the inspector's behalf has sent a letter of introduction, with contact details, to those who submitted a duly made representation.

We also publish a magazine, website, Facebook page and Twitter – all done by volunteers.

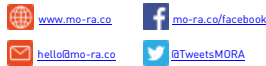
With all these plans for Shirley from Croydon Council at the moment, there is plenty going on and we need to add to our team.

# LOCAL GOVERNMENT BOUNDARY COMMISSION SUBMISSION

Dear Sirs,

**Submission to the Local Government Boundary Commission regarding the Warding pattern for the London Borough of Croydon on behalf of MORA (Monks Orchard Residents' Association)**

*MORA is an independent and non-political Resident's Association.*

I write as Chairman on behalf of the Executive Committee and members who live within the area of Shirley as designated within the London Borough of Croydon Council, Croydon Local Plan "places" of Croydon map which it has adopted for planning purposes.

We have only recently been made aware of the review of Ward boundaries in Croydon that you are currently undertaking. Having examined your criteria for deciding upon ward boundaries and sizing we would wish to make the following submission for consideration.

**Warding pattern for the London Borough of Croydon as a whole**

Whilst we have no specific proposals for the warding pattern for the Borough as a whole, we believe that the overall ward pattern should respect the "places" of Croydon as set out in the Croydon Council places of Croydon map that was drawn up and agreed some time ago and in our opinion represents the various areas, communities and recognised places of Croydon.

**Ward Pattern for the Shirley area of Croydon**

The introduction to the Croydon Local Plan defines that Croydon is a borough made up of a series of varied and distinctive neighbourhoods and areas, which are referred to as "Places". Understanding and expressing the character and what makes each "place" special and different enables sensitive planning.

Shirley is a distinct "place" as defined in the Croydon Plan as area of Croydon and we believe that the Shirley Ward should reflect the Shirley place area and is defined by the following boundaries.

To the East the area is defined by the Borough Boundary with the London Borough of Bromley. Everything to the West of the Borough Boundary is part of Shirley.

The western Boundary is defined by Shirley Road and the boundaries of the Shirley Park golf course at the point where it meets Oaks Road at the junction with Coombe Lane.

The Northern boundary is defined by and includes the south side of Long Lane (A222).

The Southern Boundary is defined by Kent Gate Way to include Addington Village and Bishops Walk but not Gravel Hill or the Roads off of it. The Southern Boundary also includes Coombe Lane from the junction of Shirley Oaks Road to the junction with Oaks Road.

We believe that these boundaries reflect the area of Shirley and is readily recognised by those living in the area as being Shirley.

This area is clearly too big to have only 3 Councillors but we have not considered in detail how the wards could be split. However, it seems logical to us that using the Wickham Road (A232) as a North/South split for the Wards would be appropriate as the road itself is a physical barrier and also marks the dividing line between two of the largest Residents Associations in the area, MORA (Monks Orchard Residents' Association) and Spring Park Residents' Association.

# LOCAL NEIGHBOURHOOD POLICE AND ACTION FRAUD

At the time of going to press it is too early for receipt of our police teams' first quarterly updates. However, it should be mentioned that at the end of 2016 motor vehicle crime, theft of and from, had increased. In some cases this had been due to vehicle owners taking insufficient precautions when leaving their vehicle. Always be on your guard!

Reported in January, Shirley Safer Neighbourhood Team, together with the Roads Policing Team, conducted operations both mobile and static in and around Bridle Road and Wickham Road during which time 19 tickets were issued, the bulk of which were for speeding. In addition 2 vehicles were seized by police and removed from the road for insurance and licensing offences. The team takes motor vehicle crime very seriously and will continue to schedule further traffic operations in the Shirley area for the foreseeable future.

In January we were advised that Croydon Borough intended to launch the use of body worn video (BWV) cameras on 9th January 2017, part of the world's largest use of BWV within a police service. The Metropolitan Police service will roll out approximately 22,000 cameras over the coming months.

## Action Fraud (National Fraud Intelligence Bureau)

(via Neighbourhood Watch)

Action Fraud has received several reports from victims who have been sent convincing looking e-mails claiming to be from Amazon. The spoofed e-mails from 'service@amazon.co.uk' claim recipients have made an order on line and mimic an automatic customer e-mail notification.

The scam e-mail claims recipients have ordered an

expensive vintage chandelier. Other reported examples include Bose stereos, iPhones and luxury watches.

The e-mails cleverly state that if recipients haven't authorised the transaction they can click on the help centre link to receive a full refund. The link leads to an authentic-looking website which asks victims to confirm their name, address and bank card information. Amazon says that suspicious e-mails will often contain:

- Links to websites that look like Amazon.co.uk but aren't Amazon.co.uk
- Attachments or prompts to install software on your computer
- Typos or grammatical errors
- Forged (or spoofed) e-mail addresses to make it look like the e-mail is coming from Amazon.co.uk



## Highclere Castle:

Many of you who have seen Downton Abbey will be familiar with the Castle and its grounds. Owned by the Earls of Carnarvon since 1679, it was transformed into a grand mansion by Sir Charles Barry in the period 1842 to 1878. The grounds were designed by Capability Brown.

In the late Victorian era it became the centre of political life whilst, in Edwardian times, with its house parties full of politicians, technological innovators, Egyptologists, aviators and soldiers, it epitomised the confidence and glamour of that era.

During the First World War, Almina, the 5th Countess of Carnarvon turned the Castle

into a hospital. Married at just 19, this illegitimate daughter of Alfred de Rothschild brought a stupendous dowry into the family which financed the 5th Earl and Howard Carter's discovery of the tomb of Tutankhamun in 1922.

Following the death of the 5th Earl, the 6th Earl returned to Highclere and lived there until 1986. During the Second World War, Highclere became briefly a home for evacuee children from north London. The current 8th Earl and Countess live partly in the Castle and partly nearby but remain closely involved in the day to day life and future of the Castle.

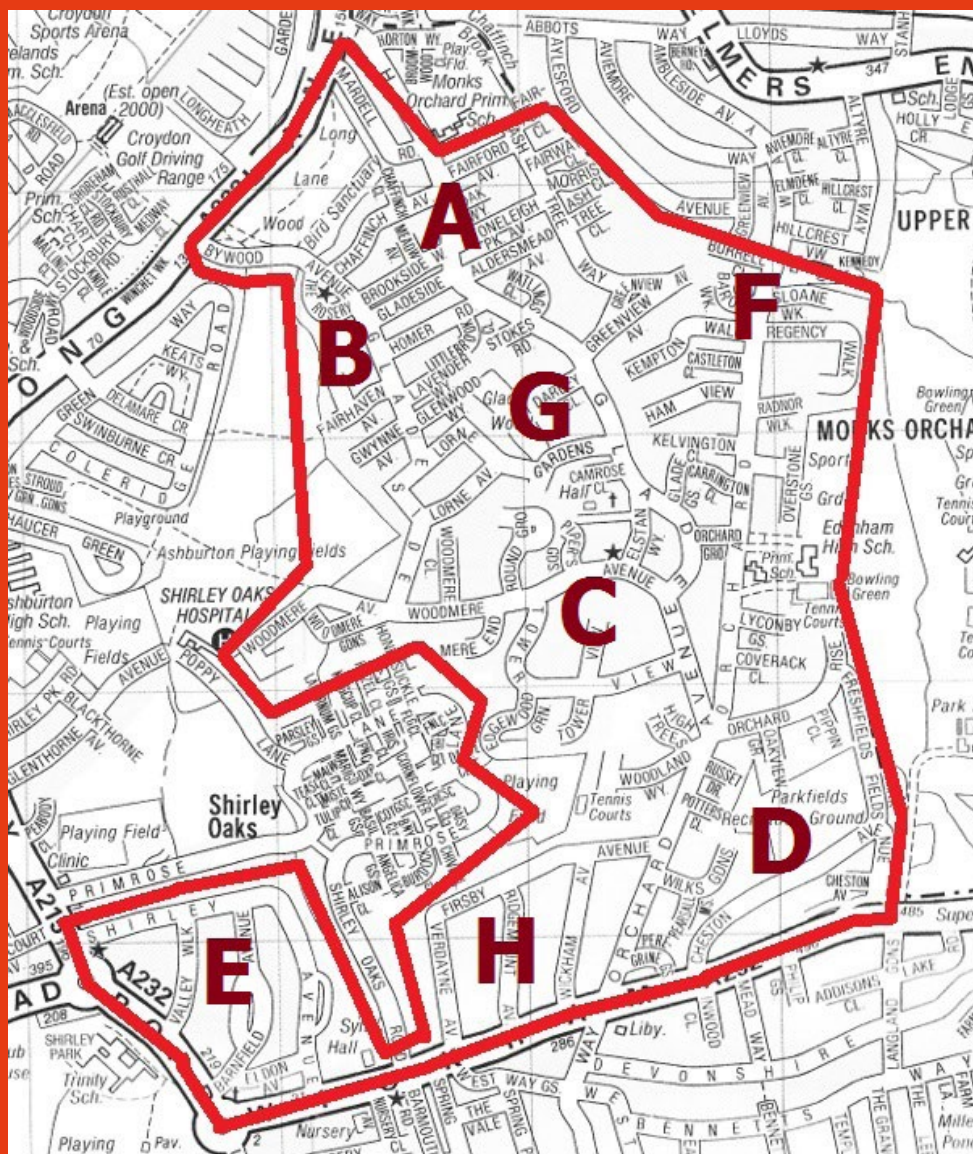

## Croydon Local Plan (CLP2)

### What happens next?

– Submission to the Planning Inspectorate for examination on behalf of the Secretary of State

The Croydon Local Plan: was approved at Full Council on 5 December 2016 and by the time you read this, will have been submitted to the Planning Inspectorate on behalf of the Secretary of State on 3rd February 2017.

The Summary of the Representations that the council received was published on the council's website on 3rd February. It is for the appointed Planning Inspector as the independent examiner of the Local Plan to determine those matters raised by representations where the council has stated 'no change.' Most of the representations are categorised as "No Change" so we will need to be prepared to challenge at the Inspector's Hearing.

Once the dates for the Hearing Sessions are confirmed by the appointed Planning Inspector they will be published six weeks in advance on the council's webpage. The Hearing sessions are likely to take place in late spring 2017.

After the Hearing sessions for the Local Plan the Planning Inspector will then produce their report, either recommending adoption, or some modifications prior to adoption or withdrawal of the Local Plan. This can

take a number of months and the overall process of the Examination from the date of submission can take up to a year.

### 64 Woodmere Avenue – Approved Delegate Business Meeting 19/12/16

Ref: 16/03749/P

**Demolition of 64:** erection of 5 three bedroom detached houses; alteration of access onto Woodmere Avenue and provision of associated parking and landscaping.

This is Tandem Back-garden development which is against current planning policies UDP H5 but which the Planning Committee seem to ignore

as they approved previous applications for this site.

### MORA Comments:

At average Habitable Rooms per dwelling of 6, Housing Density of 17.24units/ha and residential density of 103.45habitable rooms/ha, are all off the scale as given in the London Plan table 6.2. These figures would imply the maximum parking provision of two spaces per dwelling at this end of the scale.

Plot 2 has only one parking space allocated (the garage). Whereas Plot 3 has 3 parking spaces – (two hard- stand spaces and one garage).

It is considered therefore that Plot 2 has under provision for parking allocation which is unacceptable in a PTAL of 1a and is therefore in contravention of London Plan Policy 6.13.

The proposed development is in contravention of Croydon UDP Saved Policies UD8, SP20 and UDP H5. Also, the proposed development is in contravention of the London Plan Policies 3.6 and 6.13 and NPPF paras 48 and 53.

Amended plans reconfigured Plot 2 to add parking space.

## MORA abridged comments to Planning Inspector on 21/12/2016

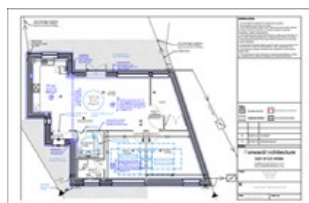
The applicant has tried to obtain planning permission for chalet bungalows and when they were refused, a Lawful Development was approved for an outbuilding, purported to be for a gymnasium. However, the built form was materially different from the approved Lawful Development Certificate. The front door is where the shower was supposed to be and two bedrooms were built where the gymnasium was supposed to be. The front door, facing Edgewood Green has a letter box (so the owner wants to post letters to himself from house to his gym!).

The structure is therefore unlawful as the built form is materially different from the approved plans and is therefore in breach of conditions 3 and 4 of the lawful development certificate. The appellant has not applied for a structure under Class E of the General Permitted Development Order (GPDO) which would give local

adjacent neighbours their legal entitlement to comment and thus to afford the LPA to consider the application against the full current adopted planning policies.

The structure results in an over-development of the site, out of keeping with the character of the area and detrimental to the spacious appearance of the street scene (prior to the erection of the outbuilding) by reason of cramped layout, prominent siting and uncharacteristic roof form and would thereby conflict with the NPPF, policies 3.5, 7.4 and 7.6 of the London Plan and policies SP1.2, SP2.1, SP2.6, SP4.1 and SP4.2 of the Croydon Local Plan Strategic Policies document.

We agree with the council's view that the structure conflicts with policies UD2, UD3, and H2 of the Croydon Replacement UDP and additionally would suggest it is in conflict with Planning Policies

H5, UD6, UD7, UD8 and UD13 of the Croydon Replacement Unitary Development Plan. The proposal provides inadequate parking provision, which would result in on-street parking at a dangerous road configuration. The proposed development would significantly reduce the amenity space for both 26 and 28 Tower View for the current occupants and for future generations and the amenity space to the front of the structure would be out of character with the frontages of surrounding properties.

**Extract from Case Officers recommendation to the Inspector:** 5.23 Having regard to the above (i.e. the body of the report), it is deemed that the 2 proposed blocks of flats of the layout and scale set out in the application will result in an overdevelopment of the site that will be out of character with the pattern of surrounding developments.

**Appeal Dismissed:** 20th October.

## Inspector's Comments:

**Main Issue:** 4. The Council has submitted a copy of its officer delegated report setting out its views on the planning merits of the case, including its reason to contest the appeal. Taking this into account and my consideration of the evidence before me, including representations from interested parties, I consider the main issue to be the effect of the proposed development upon the character and appearance of the area.

## Conclusion:

12. I find that the development would be contrary to the development plan when read as a whole. For all the reasons given above, and having regard to all other matters raised, I conclude that the appeal should be dismissed.

## 41-43 Orchard Way (New Application)

(this looks very familiar)

### LPA Ref: 16/04935/FUL

Demolition of existing buildings and erection of 2 two storey buildings with accommodation in roof-space comprising a total of 5 three bedroom and 4 two bedroom flats. Formation of revised vehicular access and provision of associated parking.

**Application Validated:** Fri 23 Sep 2016 (Note: prior to Inspector's Decision on 20th October) so it is not possible that this new application was modified to take account of any Inspector's comments for dismissal of the previous application.

Compare this application with the previous dismissed application.



Not much different from the dismissed appeal design; 9 Flats and 32 occupants; 9 parking spaces. (See above)

## MORA Abridged Comments:

The proposal would result in an over-development of the site, excessive Housing and Residential Density for the locality "setting" at a current PTAL of 1; is out of keeping with the character of the area and detrimental to the spacious appearance of the street scene by reason of cramped layout, prominent siting with uncharacteristic 3 storeys and uncharacteristic roof form and would thereby conflict with Croydon Planning Policies; SP1, SP2, SP4, SP6, UD2, UD3, UD6, UD7, UD8 UD13, UD15 and Policy H2, H5 and T2, of the Croydon Replacement Unitary Development Plan (The Croydon Plan). The proposal would also be in contravention of Policies 3.4, 6.13, 7.4 and 7.19 of the London Plan.

In order to meet the limitation of height, to respect the height of the adjacent property, the applicant has proposed to sink the development 1m into a hole in the ground, which would

potentially result in considerable increased susceptibility to surface water flooding as this location is already classified by the Environment Agency as an area susceptible to surface water flooding.

The proposal provides inadequate and unsafe parking provision, which would result in overspill to on-street parking and dangerous exits without adequate visibility spays onto a narrow slip road (Orchard Grove) between The Glade and Orchard Way. The proposed development would significantly reduce the amenity space for the occupants of the proposed dwellings for future generations and the amenity space to the front of the proposed dwellings in Orchard Grove would be dominated by car parking, completely out of character with the frontages of surrounding properties (UD13).

This proposed development as set out in the application is clearly totally inappropriate at this location and is in breach of the planning policies defined to ensure development applications are commensurate with the character of the localities.

A second motion for REFUSAL, proposed by Councillor Luke Clancy and seconded by Councillor Sue Winborn, thereby fell.

The Appropriate Densities at PTAL 1a would be Housing Density at 48.25units/hectare and Residential Density at 166.5 habitable rooms/hectare. So this proposal is an over-development for the area. 36.15% increase in Housing Density and 35.9% increase in Residential Density.

b) The parking provision is inadequate for the number of units/occupants as required and defined by the London Plan parking standards at Policy 6.13.

c) The proposed development does NOT provide any Private Amenity Space as required by the London Plan housing SPG Standards 26.

d) There is no provision for "Play Space for Children" in a proposed development that could easily accommodate greater than 10 children.

the Site Area stated on the application form is 1470m<sup>2</sup> = 0.147ha. Exactly the same site area stated for the application and approval of 41-43 Orchard Way; Ref: 16/04935/FUL – This has implications on the Housing, Residential Densities and Parking Standards.

### **Our reasons for scepticism are that:**

The Application for 8 The Glade Ref: 16/04072/OUT Site area was quoted at 713.0m<sup>2</sup>.

The Application for 10 The Glade Ref: 16/04070/OUT Site area was quoted at 683.0m<sup>2</sup>.

This gives a total combined site area of 1396.0m<sup>2</sup> ≈ 0.1396 ha

So, where has the extra 74m<sup>2</sup> come from to make the site area now 0.1470ha?

- Over development for the area;
- Out of Character of the locality and surrounding properties
- Unacceptable Increased in Housing and Residential Density for Area with Low Public Transport Accessibility;
- Residential density of 30 occupants where there

are currently just two small family dwellings;

- Car Parking insufficient for number of occupants in low public transport area;
- Lack of car parking spaces so car ownership would require overspill on-street parking; Parking Stress very near two Schools with 1,500 pupils. School Run is chaotic;
- In an area of low public transport accessibility PTAL;
- There would be loss of linked garden natural habitat for local wildlife;
- Windfall sites unnecessary to meet Croydon's Housing need;

**The approval of application Ref: 16/01738/P 41-43 Orchard Way, and this proposal will increase the total occupancy of the combined site from approx. 14 to 62 i.e. an increase of 342.86% persons over the combined Site Area of 2866m<sup>2</sup> and would increase the Housing Density from 13.96units/ha to 62.8units/ha. i.e. an increase of Housing Density of 349.86%.**

**This is a significant level of INTENSIFICATION outside of a designated intensification Area!!!!**

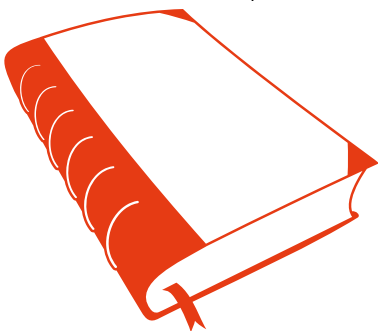
