Chairman's Comments

We are now into the New Year and I hope we are on an upward trend in our wellbeing during 2013.

We can look back on 2012 positively and with pride with things good about the UK.

Following my comments in the previous newsletter regarding travellers, I believe they have now been moved out of Croydon but if any resident has news otherwise please let me or any committee member know and we will be on the case.

Most of you will have now seen the new street lighting installed by Skanska. Some of the standards are situated very close to back garden fences which make for easy access into back gardens and of course into the actual house. We have made approaches to Skanska regarding this situation and we have been informed the locations of the standards comply with British and EU regulations. However, we have obtained the regulations and we question whether Skanska are in fact abiding by these regulations in all situations. If anyone wishes further information we can check the relevant data and the actual regulations and clauses.

Skanska have informed your committee that they could install around the standards some anti-climb spikes but these have to be located 8ft (2.44 m) from the ground. As a fence can only be 6ft (1.8m) high without requiring planning approval there is still a 2ft (600mm) gap between the top of the fence and the spikes through which to gain access.

I will make no apologies for banging on again about assistance on the committee. We have had recently both our Editor, Derek, and our planner, lan suffering mild heart attacks. Derek spent all Christmas in hospital and lan followed shortly after. Derek will be having further tests and the worst case scenario will be bypass surgery. I am sure you will join me in wishing them both well. You now realise why we need assistance as without these people MORA will cease to exist. Please contact me for further details.

To end on positive news you will read elsewhere in this issue that the planning application for development of the Shirley Green Triangle was refused. The hearing was well attended but I must add that the applicants' representatives are a tricky bunch and will no doubt try again. Again I stress without MORA's actions, this application could well have been approved.

We can also announce that our website is up and running again thanks to Nathan Reed - more info in the summer newsletter.

2012 Membership Report

Membership has been falling gradually over recent years. Although since 2011, membership numbers have gone down (by 117) the actual subscriptions collected has gone up from £3514 in £2011 to 3551 in 2012 (£37). The odd figure (i.e. not a multiple of £2) is due to one member paying £3 instead of the £4 in 2011. Also, the difference between these figures and the accounts to 31st December 2012 is due to some 2012 membership being processed after the cut off for the December 2012 accounts.

The increase in collections has been as a result of our Road Stewards distributing a membership request letter to those who have missed payments in previous years and then being more persuasive for getting the subs in from even a lower number of members. Some Road Stewards/ Area Managers have had more success in this very difficult task than others and some have actually increased membership. Those residents who have not made payments for three years or more have been removed from the membership list.

Perhaps we should decide what we do about the decline in membership – people moving or passing on – we do have about 50% Senior Citizens in our membership. We need new Road Stewards and Area Managers. Contact Diane on figure if you can help. We are pleased to announce that we have a new Road steward – Sue Winter – covering Valley Walk.

The Little Book of Big Scams

There have always been people who will cheat and rob for financial gain regardless of the devastating impact their actions can have. They view honest people as "walking wallets" to be squeezed, emptied and discarded. Fraud can happen on your doorstep, by post, over the phone or via the internet. Sadly, new technology has provided even more ways for criminals to identify and swindle the most



vulnerable. The con-men or con-ladies will shamelessly lie to us; try to tempt us with 'something for nothing' 'too good to be true offers' 'cheaper gas or electricity' or 'the million pound lottery wins'. The con artist gambles on the fact that when we discover we've fallen for his blatant swindle we will be too ashamed to report them to the Police or Trading Standards Officers.

Every year the British Public loses billions of pounds to scammers (the name used to describe all forms of fraudulent crime) who bombard people with online, mail, door to door and telephone scams. Frauds are becoming more sophisticated and because of the internet can have an international dimension. People from all backgrounds and income levels are targeted by scammers; in fact, anyone can fall victim to fraud. Prevention through awareness is a good way of protecting yourself. The Fraud Alert website <u>www.met.police.uk/fraudalert</u> is a good way of gaining information on different scams targeting consumers, tips on guarding yourself against scams and advice on reporting scams. Often, the most vulnerable to financial abuse, do not have access to a computer.

Fortunately, a dedicated police team have created a booklet 'The Little Book of Big Scams' to protect us and prevent con-men/women succeeding. The book is a good read, easy to refer to and everyone will benefit from reading it. Even those who consider themselves well informed will be surprised at the vast array of scams used to part people from their money. Its contents includes: Golden Rules; Identity Fraud;

Scam Mails; Door to door Scams; Dating & Romance Scams; Banking & Payment Card Scams; Mobile Phone Scams; Health & Medical Scams; Internet Scams, and more. It also includes Handy hints to protect vourself and what to do if you get scammed!



THE FIGHT FOR THE SHIRLEY GREEN TRIANGLE

It was with dismay that MORA learnt, last July, that an appeal had been lodged against Croydon Council's earlier decision to refuse planning permission for up to fifty assisted living sheltered apartments on the Shirley Triangle. At the time of the original planning application MORA had worked hard to address the concerns of local residents about the impact such a



development would have on their daily lives and, being fully aware that these concerns remained, immediately prepared to again examine the proposals. At the same time, around two hundred flyers, which alerted them to the appeal, were delivered to residents who would be most affected. MORA's conclusion was that the situation was unchanged and proceeded to put forward objections as to why development



should not take place. Residents again wrote and put their objections to the Inspectorate.

Subsequently it was announced that there would be a public hearing for the appeal last November and flyers which gave the hearing details were delivered to the

previously notified residents. MORA was represented at the appeal hearing by Dave King, Chairman; Ian Fraser, Planning Officer and Derek Ritson, Editor and Website. It must be said that the additional support of such a sizable number of residents who were able to attend did not go without MORA's notice and was greatly appreciated. It was with extreme relief to us all to learn that the decision by the



Inspector, on 30th November, was to dismiss the appeal. Heartfelt thanks must also go to all those residents who put their thoughts and concerns in writing to the Planning Inspectorate. Their joint effort with MORA, together with the input by Croydon Council

representatives at the hearing, we are sure, contributed to the Inspector's decision.

Part of the Inspector's conclusion was that 'an inevitable loss of part of this substantial open area and its change of character [which local policies that are supported by the National Planning Policy Framework seek to protect], demonstrates that there is no compelling reason to accept that the facilities offered are so strongly supported that the harm and losses that would be associated with the proposed development of this site would be justified.'

The Council's original decision, therefore, that the Triangle is designated Local Open Land still stands. MORA hope and

trust that our local residents who know and enjoy this area of tranquillity in our urban surroundings of Croydon will continue to do so, at the same time enabling what is left of our wildlife to have, at least, one other sanctuary in this era of extreme development.



The original developers of the Triangle's surrounding area at the time, Addiscombe Garden Estates Ltd., left the Triangle to lie dormant, presumably because they did not consider it to be suitable for development. In the view of most local residents this is still the case.

Training your dog

A well behaved and obedient dog is a loving companion and a joy to be with. An undisciplined and badly behaved animal is an antisocial pest.

The basic level of training described below would not fit dogs for the show ring, or for winning talent shows or dancing competitions, but will make them



much more acceptable to owners, neighbours and passers by.

The information has been obtained from Barry Blinks who runs classes designed to help owners train their dogs. The dogs in his classes seem to thoroughly enjoy their lessons and respond well to the training, although from talking to some of the owners it is also a social occasion when they and their dogs meet like minded friends!

While I am guilty, along with many other dog owners, of chatting away to my dog I realise that he doesn't really understand what I am saying, he just enjoys the attention (and doesn't argue or answer back like many people) When expecting the dog to respond to commands it is vital that a single word is used, that the same one is used each time when the same



action is required, and that vocal tone and body language all fit together.

Dogs are pack animals in the wild, and must accept the owner as pack leader. They must be taught that they are not in charge, and while their needs must be considered by the owner, they

should not be allowed to get away with bad behaviour. If a dog jumps up at a person, who then makes a fuss of it, it teaches that dog that jumping is acceptable behaviour. Having suffered many a muddy coat from other people's dogs I can assure them acceptable it is not. When carrying out the first training of a dog, use a confined or enclosed area, for their safety and to prevent accidents. Dogs love to play chasing, and running after a dog that is running away simply encourages it to run further. Attract its attention so that it sees what you are doing, then turn and walk in the opposite direction, when it will run after you.

The most important command to teach your dog is "Sit". This means the dog will stop, sit on the ground and not move until told to stand or come. For young dogs a hand should be placed gently under the chest and lifted, while the dog is looking at you, which will cause them to sit. If necessary get down to their level. Pushing on the hindquarters can cause hip problems in later life. Hold a hand out, palm down at waist height,



while saying sit (or any other word you choose) in a firm voice that expects to be obeyed. There should be no need to shout, the dog will respond to the tone of voice.

Dogs also need to understand "Here", which calls the dog back to you. Move away from the

animal, and then call the command, at the same time putting your hand, palm up, to your chest.

Food rewards (I use home made dog biscuits) may be used in moderation, but only when the dog has earned them.

Training never really finishes for dogs and their owners. It must be consistent, it must be firm without being harsh, and it must be continuous. Dogs need reinforcement of the rules if they are not to forget and revert to previous bad behaviour.

Croydon Voluntary Action – Community First Funding

Some of you who attended the 2012 AGM will remember a presentation from Jo Gough from Croydon Voluntary



Action, when Community First Funding was discussed.

This arrangement would enable local people to decide which local activities or groups should be supported by passing on funding. A panel should be set up to form a representative sample of 4-8 local people, ideally including the public, the private sector, the public sector and the voluntary sector.



MORA decided that we would like to be involved in this process and met with CVA to discuss the procedure. It became clear that there was no funding available for Shirley or Heathfield

wards as these were not considered deprived in any way. For the Ashburton ward, however, there was a potential funding pot of $\pounds 33,910$ for 2011-2015.

The problem for MORA was that a suitable project had to be specified, which met the CVA/Government funding priorities such as:

- Improve the environment of a local park or green space
- Increase the range of activities for young people
- Increase support for older people
- Improve the health of ward residents
- Bring different communities within the ward closer together

Ian Fraser and Derek Ritson from MORA had several meetings with the CVA people and spent some time trying to identify a suitable project which met at least one of the criteria listed above. It was soon appreciated that whatever project we came up with would require teams of volunteers. In the present climate it is almost impossible to get sufficient volunteers for any projects, indeed the MORA Committee struggles to find enough helpers, and is only surviving due to the efforts of a few key members.

The project needed to be defined, agreed and documented, including an outline implementation plan, by 31st May 2012, an extremely short timescale, given that work only started following the AGM in April 2012.

It was finally recognised by all involved that we did not have sufficient time to organise and define a project which would meet the criteria, and that we would miss the deadline and the opportunity for the Ashburton allocation of funding.

Derek Ritson confirmed this to the CVA at a meeting on 25th May. The CVA responded that hopefully there will be further opportunities in the next round of funding, although the main issue will continue to be the lack of available volunteers.

MORA will be reporting back to the AGM on this issue, explaining the difficulties encountered. Should any members have ideas on how these may be resolved we would be grateful for their assistance.

Proposal: Demolition of existing building; erection of 2 two storey four bedroom semi-detached houses with accommodation in roofspace and 1 three bedroom bungalow; formation of access road and provision of associated parking

Decision: Permission granted at planning committee on 25/10/2012. Note: MORA objected to this application. This application follows the pattern of Parkmead Close, almost opposite, which has upset many residents.

MORA have dealt with fewer applications than usual, however they have all been very important and are likely to change the character of Monks Orchard. They are back garden type designs. Some are tandem developments. All are associated with the loss of trees and the loss of habitat. All have increased the housing density of our residential area. Two of the properties have particularly modernistic and inappropriate designs. At a recent appeal the inspector accepted the principal of these alien designs. This precedent, if accepted by the Planning Committee, could totally challenge the principals of maintaining the character of an area and the intentions of Croydon's Unitary Development Plan. This sets out the planning rules which our borough should follow. MORA's success rate in persuading the Council to reject such plans has suddenly and dramatically dropped. The Planning Committee, who are all elected Councillors, appear to accept all the Planning Inspector's opinions without question and without attempting to protect their own values and the values of residents. We can only question why, and plan to improve this regrettable change in our fortune. Blind acceptance of these changes may signal the death knell of Croydon's residential suburbs.

My name is Helen Etheridge from Shirley, and granddaughter of one of your committee. I have spent the last five months teaching English to young people in the city of Chongqing, southwest China. My time here so far has been full of wonderful experiences. I am thoroughly enjoying being a teacher and



have also tried many of the spicy dishes of Sichuan, played my flute to a large crowd, stared in awe at the three natural bridges in Wulong and wandered through the magical Furong Cave.

China will soon be taking a well-earned break to celebrate Chinese New Year. My boyfriend, Yang Chen, and I have just returned from a

two week trip to Yunnan province, located in the far southwest of the country. Our trip began and ended in the beautiful town of Lijiang, which is wellknown for its leisurely and relaxed feel. We enjoyed bright sitting in the sunshine whilst tasting local delicacies such as



'tieban doufu' (a type of chewy tofu), red bean and banana with stewed milk, and rose cakes and tea. The town offers breathtaking views over the Yulong Mountains and the sky is a perfect blue. We breathed in the aromas of wood smoke and roasting yak meat and listened to the region's traditional drum music. The architecture is very different to the skyscrapers of Chongqing. Here the homes and restaurants are small courtyards with several small buildings inside, with each building displaying beautiful wooden engravings.



Lijiang is home to the Naxi people who are influenced by Tibetan culture. We saw many examples of the Naxi language, the characters of which look like pictures. 'Mountain', for example, is one line and three semicircles, resembling a cluster of hills. There were several traditional Naxi

dance performances in the town square during our stay. The energy and agility of the elderly performers, all of whom wore traditional costume, was amazing.

From Lijiang we travelled to Shangri-La in northwestern Yunnan. This is a magnificent region, with striking scenery. From our hotel we could look out onto the beautiful but infamous Meili Mountain glowing pink

and gold in the 8am sun with the moon still in the sky. We climbed to see the Mingyong glacier, a rewarding but arduous day. The walk to the Tiger Leaping Gorge was dangerously steep and the resulting



muscle ache severe but I am left with an incredible memory. We also visited a Tibetan monastery where we learned about the local religion and customs. We then went on to visit a Tibetan family who treated us to a warm fire and traditional food and drink.

Our stay in Yunnan has provided me with a further insight into the diversity of China's various cultures and landscapes and has left me with a myriad of wonderful memories. I now look forward to celebrating my first Chinese New Year and returning to another term of teaching in Chongging.

New appointments at Croydon Health Services

The NHS Trust Development Authority (NHS TDA) confirmed on 23 January 2013 the appointment of two new non-executive directors, Godfrey Allen and John Thompson. Karen Jones, a non-executive director at the Trust since 2009, will step down for family reasons.

The new non-executive directors have extensive experience in this area. Godfrey Allen was previously a non-executive director for NHS Wandsworth and NHS Richmond, and John Thompson for NHS Sutton & Merton and NHS Croydon. They will participate in Board meetings to provide advice and support. Mary Clarke CBE, a registered nurse on Merton's Clinical Commissioning Group governing body, will also join the Trust as an associate non-executive director. Mary's role will be to ensure the views of clinical staff are voiced.

Godfrey Allen and John Thompson have been appointed until 14 July 2013 and are entitled to receive £6,096 per annum. These roles will then

be advertised and substantive appointments made following an open recruitment and selection process.

On 4 February Croydon Health Services NHS Trust appointed John Goulston as the new Chief Executive. John, who had been the Trust's interim chief executive



since 1 May 2012, was appointed after a rigorous selection process, which included an interview and a presentation to clinicians and senior leaders. He has announced plans to tackle the challenges facing the Trust, including appointing a permanent Chief Operating Officer to support the Trust's clinicians and senior management team in improving performance and delivering better care for patients.



MORA Finances and Trends 2004 – 2012

We have undertaken an analysis of our MORA finances over the recent past to see what trends we need to be aware of. Looking at the graph below, you can see that prior to 2007, when we last increased our membership subscriptions, we were over spending and during 2005 only managed to have a surplus after we decided to hold our monthly committee meetings in a committee member house rather than hire a committee room. After increasing the membership subscriptions in 2007 we decided to hold proper meetings in the Tamberlin Room at St John's Church. The other method of increasing funds was from the Fees for the Advertisers in the newsletter. Except for a fall in 2009 we have managed to collect fees to help sustain our expenditure - mainly to fund the printing of the quarterly newsletter, hall hire for the AGM and committee meeting room hire. However, the slow decline of membership is beginning to affect our finances as can be seen by the difference between income and expenditure in 2012. [See report page 5].

As stated in our membership report, in order to maintain and represent our membership on planning issues and to meet the demands of the Localism Act, we need to reverse the decline in membership as people move on and pass away.
