CHAIRMAN'S COMMENTS

We have gone through some changes in the recent months since the AGM.

Firstly, we have welcomed into the committee Ngairé Sharples as our new Secretary and Sony Nair as a new committee member.

We have also been seeking a Vice Chairman to support me and help push MORA forward and am pleased to announce that our Editor Kevin Martin and Sony have agreed to take on this responsibility jointly. They have some great ideas and visions and will be pushing us forward around their already busy schedules.

You will notice we have also improved our identity and how we look (*read more further on in this magazine*). We are also becoming 'cool' with our new website; www.mo-ro.co, Twitter; www.mo-ro.co/twitter and Facebook; www.mo-ro.co/facebook. This is all down to Kevin and Sony but being old I'm currently not up to date with all this 'stuff' but will quickly learn. Please bear with me.

It was also great to see our new look at the Edenham School Fete, and how the community came together to support each other. We hope to be at more events in the coming months, so please follow us on social media to keep track.

Now the election is over we know who we are to be governed by for the next five years. Let's hope the deficit can be reduced.

Those of you who read the newsletter would

note the current Croydon Council representatives are preventing our elected MP, and GLA representative from representing constituents on planning matters. Indeed, we e-mailed Tony Newman (leader of the council) and it was deleted as unread. This is clearly how the council see us: just a thorn in their side.

I, along with two other members of the committee, and representatives of other residents associations, was invited to attend a meeting Chaired by a Croydon Councillor to enable us to air our views of the activities of the Council.

It was interesting to hear the questions from the audience and how much they feel they are not listened to; in particular, comments regarding planning applications and how their Local MP or GLA member can no longer make a referral on minor applications, i.e. to refer the decision to a planning sub-committee rather than allow the decision to be taken by a delegation of planning officers. In fact we received an email from Julie Belvir, Director of Legal & Democratic Services, stating that only planning applications of a certain size and scale are referable by MPs or the GLA member. This precludes us the people from objecting without difficulty, to residents building habitable accommodation in their back gardens (beds in sheds).

I understand it is proposed to hold regular meetings with Councillors so they are kept up to date with Residents'

Associations activities and I will ensure you are also informed.

Those of you who are observant will not have failed to note the missing bench on the grass triangle at the junction of Orchard Avenue and Orchard Way near the bus stop. The bench was erected some years ago in memory of Hugh Allerdyce, a founder member of MORA. It appears a wayward driver mounted the pavement and destroyed the bench. The committee is looking at a replacement which when purchased will be securely fixed with steel brackets into a concrete foundation.

I must comment on an item raised by a Councillor at our AGM regarding our underground system. It appears he advocates the underground system coming out as far as Croydon and other areas south of the Thames. I had to inform him that the reason the underground system is predominantly north of the Thames is due to the complex nature of the strata and the number of underground rivers. As I said, the system may one day extend further but it certainly won't be in the lifetime of anyone present. I only wish people would research their subject before speaking about something they seem to know nothing about.

The next issue of our magazine will be in Autumn so I wish you all a pleasant summer in what ever your plans are.

Dave King, Chairman of MORA, opened the meeting by welcoming all friends and members present, as well as guests Gavin Barwell MP, Councillors Andrew Rendle, Stephen Mann, Richard Chatterjee and Sue Bennett. GLA member Steve O'Connell and Councillors Mike Fisher and Maddie Henson arrived after the start of the meeting. Sgt Marcus Moore and PCSO John Iles of the Shirley Safer Neighbourhood Team and Trevor Ashby and Colin Poole from Spring Park Residents Association were also welcomed. A special welcome was given to the guest speaker Mike Bell, who was accompanied by Daniel Pople, both from the Croydon Health Services NHS Trust.

Minutes of 2014 AGM

These had been published in the Summer 2014 newsletter and were approved by a vote.

Chairman's Report

Dave King

Dave warned all to be aware of anyone acting in a suspicious manner locally as he understood there had been a spate of burglaries recently.

He emphasised the need for prompt delivery of the newsletters which often contain details of time-sensitive events. He asked that the Committee be informed of any undue delays. He also asked to be informed of new residents so that they can be invited to join MORA.



On 17th May 2014 a very successful party for Area Managers and Road Stewards was held to celebrate the 90th anniversary of MORA.

On Planning issues Dave expressed concern that recent changes meant that neither Gavin Barwell nor Steve O'Connell are able to make a referral or speak on behalf of residents on minor planning issues such as extensions and back garden developments. He suggested one of the councillors present respond later.

Dave was also unhappy that residents are no longer informed individually of planning applications; instead easily removed notices are attached to nearby lampposts.

The bench in memory of Hugh Allerdycy has now been damaged beyond repair.

Michael Nash was presented with a certificate of Honorary Life Membership.

Treasurer's Report

Terry Greenwood

Income and Expenditure year

ending 31st December 2014.

For the first time in 12 years more was spent than was taken in. This was due to the party held last year, although many of those involved did not claim their full expenses. Overall MORA was still in profit by £11,696. Detailed accounts are in the spring newsletter.

MORA donated £100 to the Girl Guides trip to Switzerland.

The Editor of the newsletters has negotiated down the cost of printing them.

We now have Affiliated Members, for supper club members from outside our area. These receive the newsletters but have no voting rights.

Membership Report

Derek Ritson

Derek had taken over the role of membership secretary following the resignation of Vilas Patel last year.

Derek stated that MORA would collapse without the support of Area Managers and Road Stewards. The membership fees they collect keep MORA

They visit local restaurants once a month for lunch or supper; there are no membership fees, but raffles are held to raise money for their Christmas party. Planning Report

Derek Ritson

Derek took on planning following the resignation of Ian Fraser. He outlined the most important issues which had arisen during the year:

31A Woodmere Avenue – The planning inspector allowed an appeal for an outbuilding, which was larger than the host bungalow, and had all the facilities of an independent dwelling. MORA was not satisfied with the inspector's response to our queries and submitted a dossier of evidence (endorsed by Gavin Barwell) to the Parliamentary Ombudsman. It seems that an inspector is not accountable to the ombudsman other than by a legal challenge. Gavin will be following this up with the Minister of State for Planning.

168 Orchard Way – An unauthorised development was begun during the summer. An enforcement officer stopped the work and requested a planning application. The planning sub-committee allowed the

application, ignoring previous conditions imposed by the Planning Inspector. MORA has raised a complaint and expects to take this to the Local Government Ombudsman.

110 The Glade – An application was put in for the demolition of an existing structure and the building of a 1 bedroom dwelling in the rear garden of this property. The application was refused.

There have been additional successes, including the appeal dismissal of the application for the demolition of 62 Woodmere Avenue and the building of 5 three bedroom homes; also the appeal dismissal of the backland development of 3 gardens on Gladeside.

Derek also advised that MORA cannot object on any permitted development applications as objections can only be received from adjoining neighbours, although we are happy to offer advice.

Nominations for the Committee 2015 to 2016

Dave listed the resignations which have taken place since last year, Mary Evans (Secretary) Vilas Patel (Membership) Barbara Turner (Advertising) and Julie Cornell (Transport and Highways) He thanked them for their past efforts. Derek has taken on Membership and Mary Jennings Advertising. MORA is in desperate need of a secretary, which will mean taking minutes at meetings, managing the email account and other admin duties. A vice chair is also needed when Dave is not available.

Nominations for those standing for the Committee were shown and the vote to elect was carried.

Security Report

Sgt Marcus Moore

Sgt Moore gave a brief overview of his career, a local man he has served in Brent,

Harlesden and Richmond. The Safer Neighbourhood Team is based in Addington Village. There are 5 officers including himself and PCSO John Iles. He thanked MORA for the invitation and added that he was impressed with the turnout and level of support shown.

The team issue monthly updates electronically, and are able to deliver a few hard copies, but do not have the capacity to do this generally. The quarterly Ward Panel meeting is open to the public, but anyone who has a query should ask him or John Iles or send an email.

In response to a prepared question Sgt Moore stated that the team do patrol the area, John Iles is out 80-90% of his shift. Some officers may be in unmarked cars, and at times plain clothes officers are on patrol. They do sometimes have to assist outside the area when immediate attention is required.

MP

Gavin Barwell

Gavin thanked MORA for its work which helps both the MP and Councillors.

Gavin gave details of local issues he has been working on. He wanted the Hammerson / Westfield redevelopment to go ahead as soon as possible. The result of the public enquiry into the compulsory purchase order should be through in June or July, which is the final legal barrier.

He has supported Croydon University Hospital in its efforts to get a new A & E department.

There are issues with the rail service to central London. Much needs to be done by Network Rail to keep services reliable, especially at London Bridge.

He regretted the changes to the rules on planning referrals and thanked Derek for his work on planning issues.

He thanked MORA for all the hospitality given to him over the past 5 years.

GLA Member

Steve O'Connell

Steve is the representative for Planning Policing and Transport. Around 70-80% of his casework is devoted to transport. The Mayor has overall responsibility for planning and writes the London Plan. He also regretted the withdrawal of his ability to refer applications but stated he can still object on larger developments.

Ashburton Councillor

Stephen Mann

Stephen reiterated Gavin and Steve's comments about the work of MORA. He is on the Planning Committee so is restricted but his colleagues have been working with Derek. He has been working on the problem of flooding from Chaffinch Brook; a very long term solution may be to open it up as was done with the Wandle. New measures are in place to prevent travellers setting up in the area. There have been 11 prosecutions for fly tipping.

He has been campaigning for the Bakerloo line to be brought to Hayes.

Shirley Councillor

Richard Chatterjee

Richard referred to 31A Woodmere Avenue, where the principal problem is enforcement and getting evidence. He also regretted the approval by the Planning Inspectorate of the building at 168 Orchard Way, which all Shirley Councillors had spoken against.

Prepared Questions for Elected Representatives

To Gavin Barwell

What is the situation relating to our complaint to the Parliamentary Ombudsman's referral to the Planning Minister and what will happen in the event of a change of minister after the election?

Gavin has not yet received a formal reply but hopes there will be a change in the law

to make inspectors more accountable. This is a good test case and he hopes that it will be taken forward, whoever the next planning minister is.

To Steve O'Connell

The 367 bus stop in Orchard Avenue for Tower View is situated in a muddy grass patch. Could it be relocated to the tarmac area?

Steve will liaise with TFL and report back.

To Stephen Mann – Planning Committee

Planning notices are put up on lamp posts etc and are sometimes removed intentionally or otherwise, which results in local residents being unaware of a proposed development. Previously letters were sent out to residents but this was stopped on cost grounds. If the cost of a planning officer's time and travelling expenses, plus the cost of laminating and fixing straps is compared to that of sending out perhaps a dozen

letters it is doubtful whether money is being saved.

This has been a big issue in the MORA area. The planning officers referred to the Development Management Procedures Order 2010 which means that the council does not have to advise adjoining neighbours and put the notices up. Croydon is facing huge cuts but consideration should be given on how this can be better done.

Residents had sent in a petition about 31A Woodmere Avenue as they are convinced the outbuilding is being used as living accommodation, in contravention of the conditions of approval. They wished to know whether any enforcement action had been taken. The tax band for the property is E, and surrounding properties is F, although these do not have the additional building.

Stephen has raised the matter with officers and an investigation is ongoing.

Sgt Moore questioned how the police had prevented evidence being gathered by residents concerning this property. Derek Ritson replied that one resident had put up a CCTV. The police were called by the occupiers of 31A Woodmere, and told the residents to remove the camera.

Andrew Rendle – Councillor

A question was put concerning the retention of open spaces and how to prevent travellers gaining access to these.

Andrew replied that the Council works to get the travellers removed legally

as soon as possible. Actions have been taken to prevent those getting vehicles onto playing fields and talks are proceeding with travellers' associations to find suitable alternative sites in Croydon.

The issue of Long Lane Woods was raised. Andrew replied that he had an on-site meeting arranged for the following week and invited MORA to send a representative. Martin Buchanan will liaise with Councillor Rendle.

Invited Speaker – Mike Bell, Croydon NHS Trust

Among a huge number of other activities, the Trust opened Purley Memorial Hospital last year. Overall they now have 18 sites over the borough. On average every day 10 babies are born in CUH, there are 100 operations, 350 people attend A & E, and there are 1000 outpatients at CUH and Purley.

There are 3,500 staff over all the sites. The north of Croydon has the worse deprivation, worsening as the population grows. 1 in 5 people are not GP registered and use A & E as their primary care.

Target waiting time in A & E is 1 hour 20 minutes. Post Christmas actual time for 1 in 3 people was over 4 hours. This became a major incident.

The Trust has social workers aiming to get patients back into their homes as soon as possible.

Mike Bell and John Galston, Chief Executive, introduced "Listening into Action" which took on staff views and ideas for improvement. Major successes include "home for lunch" which means patients can be home by lunchtime. Physical Wednesdays mean that the executive team are out on the wards or community services. The public have

attended a series of "listening into action" events, and he will have regular surgeries to liaise with the public. They are the first NHS organisation to achieve accreditation with the scheme.

The children's diabetes service was rated as excellent. Jointly with the council a service for young people with learning difficulties was rated best in London for the second year running.

A new approach to breast feeding has been introduced. With the Council they secured £1.5 million to set up Croydon's Breast Staff.

They are supporting older people by assisting them to stay in their own homes.

They have new initiatives for dementia sufferers.

Together with others they are working to provide hospital grade care in patients' homes, and are working with GPs to speed up entry to hospital.

Staff roles are now more obvious and open, especially matrons.

The Trust is seeking continuous improvements and would appreciate the public's views.

They are hoping to re-develop the A & E department which had been built for 70,000 patients a year but was now serving 130,000.

Prepared question for Mike Bell

How will the hospital deal with the increasing population?

Mike hoped that the planned development programme would help. Primary care is the biggest challenge over the next 5 years, ensuring that there are enough GPs.

Derek Ritson asked if the Trust spoke to planners, Mike replied that information from the Council and GLA is used to plan their services.

Questions from the Floor

Q. Should libraries be run on a subscription basis?

Maddie Henson- Not all could afford to pay and the service should be for all.

Mike Fisher -The core library service is a legal requirement and cannot be charged for.



Q. Why are more high rise office blocks being built when many are standing empty?

Gavin Barwell - To attract major businesses back to Croydon, bring quality jobs to the town, new purpose built offices are needed. Some buildings are being considered for conversion to residential housing.

Q. What is to happen to Taberner House?

Stephen Mann - Schemes are coming up before the Planning Committee, and he believes there are proposals to provide 30% affordable social housing.

Q. A resident had been taken round the dementia wards but as there was no one in charge of activities the patients were not getting any stimulation. Also after a visit to the Rheumatology Department she has a 9 month wait to see a consultant.

Mike Bell - Will look into both issues

Q. Who decides the value of properties for council tax, and what is the basis of the assessment?

Mike Fisher - The valuation officer decides. The decision

is made on the basis of current value following a visit. There is a right of appeal.

Q. A resident asked about mental health issues

Mike Bell - There are several mental health trusts and it is hoped to break down the different problems which also include physical well-being. Significant progress is anticipated over the next 12 months.

Q. A further question from the floor also concerned mental health but was largely inaudible.

Andrew Rendle - One of his roles is Deputy Cabinet Minister for People and Communities, which covers health and adult social care. Work is being carried out on mental health and talking therapies. He is also taking forward a lot of work on autism and is Croydon's autism champion.

Dave King

Dave King closed the meeting by thanking everyone for coming and wished them a safe journey home.

SHIRLEY NEIGHBOURHOOD CARE SCHEME (SNCS)

Perhaps a little of the history of this organisation might help. Shirley Neighbourly Care Scheme was set up by the Shirley Group of Churches forty years ago. The Co-ordinator would be asked to find drivers from a list of volunteers to take local people to health appointments. This worked well while Co-ordinators were available but in the early 2000's it fell into disrepair. In 2004 Churches Together in Shirley (CTIS) decided to revive the project under the name Shirley Neighbourhood Care Scheme and many of the local churches agreed to support SNCS financially.

Shirley Methodist Church also agreed to provide an office free of charge. The decision was taken to employ a paid part-time Volunteer Co-ordinator and in May 2005 Christina Lyon-Williams took on this role.

Over the next 9 years SNCS went from strength to strength not only providing lifts to health appointments but also in 2010 a lunch club (Shirley Diners) was established with some help from Croydon Council who agreed to meet the salary of the new lunch club Co-ordinator, Danuta Plummer, and later that year SNCS became a Registered Charity. A shopping bus runs to Tesco's every Wednesday and a Befriending Scheme has been developed to visit lonely folk once a month. In May 2014 Christina retired and was succeeded by Sue McVicker who is doing a great job. In the last financial year total expenditure exceeded £23,000 as against total income of £24,000. More than 50% of

the expenditure comprised salaries for the two paid employees whereas only £5734 of the income was guaranteed from the Council and churches.

In view of the above, fund-raising has always been an important aspect of SNCS and for the last few years an annual Quiz Night and a Shirley Open Gardens weekend have been held which together raised almost £2,000 last year.

SNCS depends on unpaid volunteers to man the office Monday-Friday mornings, help with Shirley Diners on Thursdays, drivers for the shopping bus, drivers to deal with health related appointments and of course men and women willing to be befrienders.

You may already use SNCS yourself or you may be a volunteer. On the other hand you may be wondering if you too could be a volunteer in one capacity or another. If so ring Sue McVicker at the office on 020 8662 9599 or email her at sncs1970@gmail.com

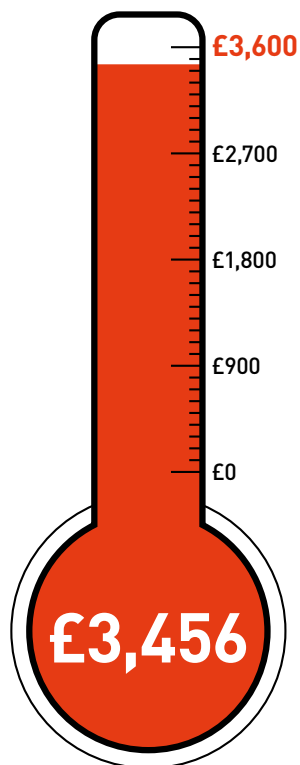
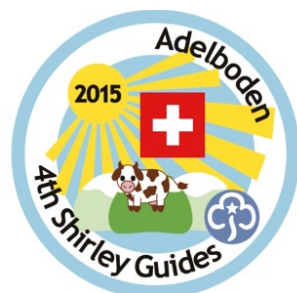
UPDATE ON 4TH SHIRLEY GUIDES FUNDRAISING

UPDATE FROM SHIRLEY SAFER NEIGHBOURHOOD POLICE TEAM

The months of March/April showed that burglaries in Shirley remain low. In the four weeks up to mid-April there were two burglaries and two attempted burglaries. The police stress, however, that residents must not get distracted by bogus callers or persons offering to do work on the house or garden, allowing them entry to property. Motor vehicle crime offences have also decreased. In the four weeks to mid-April there were four thefts from motor vehicles and no theft of motor vehicles. Key routes around the Ward continue to be monitored by officers in respect of speeding traffic. Recently speed issues were monitored, in conjunction

with Croydon Council, in Orchard Avenue. The findings were generally indicative of average speeds in urban areas and the local authority did not believe there was sufficient concern as many other roads around the area generally have a much higher average speed. With regard to Anti-Social Behaviour (ASB), the team continue to patrol key estates to provide high visibility reassurance and reports of ASB have significantly reduced.

An extremely involved case recently ended successfully for the team when a local woman, who carried out prolonged and protracted disputes over five years towards many victims/neighbours, was given

a custodial sentence. The evidence went back a number of years, with many victims and witnesses attending the four court dates. Restraining orders were also issued against the defendant so that each family involved is now protected indefinitely. The team believes that this case proves we can all work together to stamp out this type of behaviour in our neighbourhood.

**If wishing to report various issues/concerns –
Frequently asked Question**

ABANDONED VEHICLES

"There is a car outside my property parked on the road for the last few weeks and I believe it has been abandoned. How do I get it removed?"

Any information in regard to abandoned vehicles is useful in order to make sure the vehicle has not been stolen. Once you have called 101 to report the vehicle a check is done to ascertain if there are any reports on it. If there are not then the anti-social behaviour officer will contact the

Council's abandoned vehicles' team on 020 8255 2718, as it is down to the Council to deal. Their procedure is as follows: First visit – Enforcement Officer visits the targeted vehicle to confirm that, in their opinion, the vehicle has been abandoned. Photographs and a site visit report are made during this visit. If the vehicle is suspected as being abandoned, the officer will affix a self-adhesive seven day notice on the

vehicle. If the vehicle is a wreck or is a clear health and safety risk to everybody then the visiting officer can immediately order the vehicle to be removed for disposal. Second visit – If the vehicle has not moved within the period of the seven day notice and no response has been received for the letter of enquiry, the targeted vehicle will be immediately marked for collection and subsequent disposal by the Council's authorised contractor.

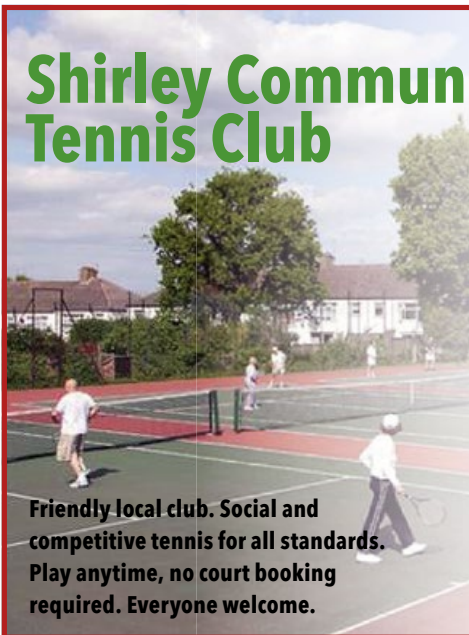

**If wishing to report various issues/concerns –
Frequently asked Question**

FLY TIPPING

"I saw a van dumping a load of material and waste by the garages at the rear of my property, what do I do now?"

This is a criminal offence for which the Council will prosecute. If you see someone fly tipping, please call the police whilst it is still happening on 101. To report an instance of fly tipping call the Council Pollution

Team on 020 8760 5483 with as much information as possible (for example, a license plate or description of the vehicle). The Council and police then work together to find the suspects and issue them with either a fine or prosecute, which could lead to a custodial sentence. The Council can also seize the vehicle/s involved. The Council is not responsible for clearing

waste on private land but will use the relevant legislation to ensure that those dumping waste on private land are prosecuted and any clear up costs recovered from the offender. In some instances this may also apply to the owner of the land, who may be liable for prosecution if they allowed their land to be used for dumping.

A NEW APPROACH TO WASTE AND RECYCLING COLLECTION



As you should be aware by now, Croydon Council is rolling out a new approach to waste and recycling collection. We would really value your help in ensuring that residents are aware of the changes.

You and your neighbours in the area should have recently received a new timetable for waste & recycling collections. Residents can also check their collection day online www.croydon.gov.uk/bincollect as well as download the latest calendar for your specific road. It would really help us if you could make people aware of the changes by informing your friends and neighbours in the area if they didn't already know.

As a reminder, since the 1 June, council staff and our contractors Veolia who previously worked in independent teams have joined forces to cover eight local areas.

Each local team will have an operations manager overseeing general waste collection, recycling, street cleaning and fly-tipping enforcement officers. The eight teams will have one or several trucks on patrol in each area at all times.

The new structure's benefits include:

- Faster responses to issues called in via the council's contact centre
- Better-planned routes through

more information on how much waste each street produces

- Improved co-ordination, such as timing collections with street cleaning

Croydon Council and Veolia are committed to ensuring no resident goes longer than the number of days listed below between their last collection under the old system and their first collection under the new village-styled approach. The number of days between:

- Refuse collections will not exceed 15 days.
- Food waste collections will not exceed 10 days.
- Recycling collections will not exceed 10 days.
- Garden waste collections will not exceed 15 days.

To achieve this we are scheduling additional landfill waste, food waste and recycling collections across the borough. Please leave your bin and boxes in a place where the waste & recycling crews can get to them and we will return to the curtilage of the property.

Once again we would like to thank you for your support during these changes.

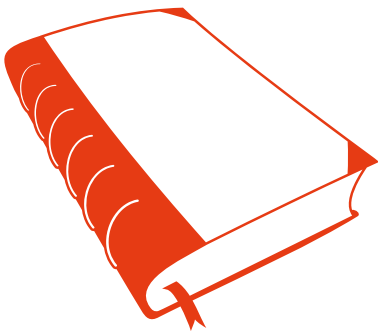

ADVICE FROM SHIRLEY SAFER NEIGHBOURHOOD POLICE TEAM

**If wishing to report various issues/concerns –
Frequently asked Question**

NOISE – “What do I do if I can hear a party happening nearby in the middle of the night which is disturbing me?”

The Council has powers to deal with noise that is considered a statutory nuisance. A statutory nuisance is determined by a number of factors including, but not limited to; type of noise, volume, frequency, duration and its impact on others. The Council generally adopts an escalating approach to noise enforcement and can deal with unreasonable noise from loud music, parties, dog barking, car and house alarms. The law enables the

Council to take action against those who cause a noise nuisance, which can result in a fine and confiscation of any equipment causing the noise.

The Environmental Health Officers (EHOs) attend to assess the situation and if needed can request support from the police. The EHOs are contactable on 020 8726 6200 or by using the My Croydon app (which can be downloaded from the Apple App Store and Google Play Store). While the Council's legal powers enable them to deal with unreasonable noisy activities (Statutory Nuisance), they cannot deal with

noise considered to be 'normal domestic noise' which arises from people going about their normal day to day activities in a reasonable manner such as: noise that can be heard due to poor insulation, for example neighbours talking or walking on wooden or laminate floors; children playing in gardens or in the street; doors being closed; road traffic (other than vehicle alarms).

“My neighbour deliberately makes noise throughout the day and night and it is affecting my quality of life. Who do I speak to about this?” Tackling and dealing with ongoing incidents of anti-social behaviour (ASB) often requires a multi-agency approach and the Council work closely with the police and other partners to

bring ASB to an end as swiftly as possible. Call 101 to report the incident to the police and this will be passed to your local borough for an officer to make contact with you to ascertain the exact details of what has occurred. The officer will then advise you whether police will deal, or another agency. If further assistance is needed from another agency then you will be given their contact details. Alternatively, you may wish to report any nuisance, or ASB you've experienced, directly to the Council. This can be done by calling on 020 8726 6000 or emailing the ASB team directly at ASBTeam@croydon.gov.uk If you are a Council tenant you are advised to contact your housing officer on the same telephone number.

TRADING STANDARDS ALERT

ROGUE TRADERS AND SCAMS

Bromley Trading Standards in partnership with the Metropolitan Police and Bromley Adult Safeguarding have initiated a campaign to raise awareness about Rogue Traders and Mass Marketing Scams which are particularly affecting older persons and vulnerable adults in our local communities.

To raise awareness we have produced new publicity materials urging family, friends and carers to look out for the older persons and vulnerable adults they know and to report anything which they are suspicious or concerned about.

This will allow Trading Standards to gain valuable information about rogue traders operating in the borough and most importantly give those affected the advice, support and assistance to deal with the problems they have become a victim to.

Rogue Traders are generally those who “cold call”, i.e. knock without an invitation and offer to carry out, often unnecessary, works on homes and gardens. They make untruthful statements and carry out shoddy work with the intention of obtaining as much money as they can.

Mass Marketing Scams are mass-produced letters made to look like personal letters or important documents, in the hope of tricking the recipient into sending cash, making money transfers or disclosing personal information such as bank details. People have been known to send thousands of pounds to these scams.

Courier Fraud involves fraudsters who phone and trick victims into handing their bank cards and PIN numbers to a courier on their doorstep. The cards and PIN are then used to buy goods and take cash from the victims account.
