PLANNING NEWS

The last planning news focused on the proposal to demolish nos. 1, 3 and 11A Elstan Way and build 4 three bedroom houses, 3 four bedroom houses and 2 five bedroom houses on the site which adjoins St.George's church. The Council has been considering this scheme for over two months and so Sunley Homes, the applicants have appealed against its non determination. The appeal is be determined by way of an informal hearing. A new application has also been submitted by Sunley Homes for the same site. This reduces the number of houses from nine to six, one of which would have four bedrooms the remainder having five. MORA welcomes the reduction in the number of houses but continues to have concerns over the implications for those living around the site, traffic on Elstan Way, and the continued use of the church hall as a valued community facility if new residents complain about noise from the hall.

Even more disturbing for neighbours is the proposal by British Petroleum to redevelop the petrol filling station on Shirley Road opposite the Trinity School entrance. BP anticipate creating a bigger petrol station with a much bigger sales area and car wash. The nearest equivalent would be the Tesco Metro filling station and shop, further down Shirley Road. The most objectionable element of this scheme is that it anticipates using one half of a pair of semi-detached houses as part of the sales area. The other house remains occupied and understandably the occupiers are very unhappy about the possible impact on the quality of their lives. MORA has objected comprehensively to this proposal and in the strongest terms.

Better news on the two proposals to redevelop the buildings and yard of H.W.West & Sons at 139-141 Shirley Road. One scheme to redevelop the site to provide 10 houses as well as offices and flats has been withdrawn. The Council has also refused permission for the alternative scheme to build 14 houses on the site

The Council has finally decided that it does wish to reinstate the Burrell Close / Greenview Avenue footpath. A formal notification period is now being undertaken and it could still be some time before the footpath is actually put in place.


