PLANNING NEWS

Cemetery Proposed for Shirley Oaks

In the last newsletter MORA reported that Lambeth Council had sold its tree nursery at Shirley Oaks by auction. The new owner's intentions became clear when in January a planning application was submitted for the use of the land as a cemetery. The proposed site is the area of land off Poppy Lane bounded by Laburnum Gardens, Parsley Gardens and Woodmere Avenue.

The land is designated as Metropolitan Open Land by the Council which protects it from new building development. However, the Unitary Development Plan indicates that in principle, cemeteries are an appropriate use on such land together with appropriate small ancillary buildings.

The trouble with this proposal is that we don't know yet what it entails as no details have been submitted. There is no indication of the size, location or function of any buildings. The provision for car parking or access remains a mystery as does the layout of the site and how it is proposed to be used.

MORA has objected to the proposal on the limited information currently available and has requested that the Council must find out much more before it can even entertain the proposal. Local people must be kept informed of all the details if and when they are submitted.

There would be a tremendous impact on the amenity of people living around the site which doesn't bear thinking about as well as other problems associated with drainage. MORA will be working hard to resist this proposal and when more details emerge will be mounting a campaign of opposition. If we can beat off Tesco we can certainly defeat this outrageous scheme.

If you want to hear more, come to the MORA Annual General Meeting on the 27th March. Your local Councillors will be there to answer questions.

Other Development News

A new planning application has been submitted for the redevelopment of the H.W.West & Sons site at 139-141 Shirley Road. Previous proposals for residential development were refused by the Council. In this instance it proposed to demolish the existing buildings and to redevelop the site to provide two storey buildings with accommodation in the roofspace comprising offices on the ground floor and 4 two bedroom flats above, together with the erection of 14 three bedroom houses and a new vehicular access on to Shirley Road and Primrose Lane. MORA is worried about the loss of amenity to the residents of Shirley Avenue as well as the implications for traffic on Shirley Road and Primrose Lane as this site is close to the ambulance station and to other busy junctions.

The Council decided to resist the proposed development of land at the rear of houses on Elstan Way and Woodmere Avenue close to St. George's Church. A lot of objections have been submitted against this further back land development. The only reason the Council objected, however, was the poor access and inadequate sight lines from the proposed access road. The developers appealed against the Council's non-determination of the application and an informal hearing was held at the Town Hall on the 18th February. We await the outcome with interest.

SECURITY MATTERS



I have now been on the Monks Orchard Beat a year and on this anniversary I would like to bring to your attention the matter of BURGLARY as over the last year I have found that the SHIRLEY area has been targeted on several occasions.

I would remind MORA members that although flats and houses in inner city areas often stand a much greater chance of being burgled, the risk is not restricted to them. If there is no one in all day, and your home is not overlooked, you will need to take particular care. The majority of burglaries occur during DAYTIME – not at night as many people think, and intruders usually attack downstairs at the rear. In many cases a burglar can be in and out in just a few minutes.

May I take this opportunity to remind householders of detached houses they are more at risk than semi-detached or terraced . This is because they are often secluded, and the neighbours may not be able to see or hear the burglar at work.

Houses or flats near ends of streets or backing onto alleyways, parks or wasteground are particularly at risk because of the ease of access.

During the past year I have noticed many properties where I have been able to gain access to the rear garden with ease and not been detected by the householder; if I can do this, a burglar can certainly do the same.

BE AN ALLEYGATER - "GATE UP"



Many Houses in the MORA area have patio doors. This may give you a good view out but may weaken your security because they are normally situated at the rear and at ground level.

May I also remind MORA members where possible to mark your worldly heirlooms with your Post Code or the first two letters

of your house name which will devalue items for the burglar and assist Police in making them more traceable.

AVOID VAMPIRE SELLERS

Bloodsucking salesmen are preying on the vulnerable and members of the public who are mature in years, with high pressure sales techniques known as "vampire selling". Dodgy dealers exploiting people's fear of crime by selling usually security equipment. They call at 7.00 a.m. when the housholder is busy just to get them to go away the householder will sign anything thus committing themselves to something they do not really want, giving the salesman the opportunity for a return visit.

Although this sales technique is not illegal, be aware that these people may visit your area soon. Surrounding boroughs have fallen victim to these people who normally come from the Midlands, and target a particular residential area in numbers.

GREAT BOOK SALE



FREE RUBBISH COLLECTION

Don't miss this opportunity to be rid of all your unwanted rubbish which is not normally collected by the weekly Council collection.



PLEASE FOLLOW THESE GUIDELINES:-

- Items for disposal must be put out at the front and <u>CLEARLY</u> <u>IDENTIFIED</u> for rubbish collection (to avoid confusion with items not required for disposal).
- Place as near to the footway as possible by 9.00 a.m. (Be sure not to obstruct the highway or footpath).
- Please assist in transferring rubbish to the rear of the vehicle, <u>BUT</u> DO NOT LOAD.
- Please be considerate with size and bulk of the items to avoid damage to the vehicle.
- Any TRADE or COMMERCIAL waste (including builders' materials) WILL NOT BE COLLECTED.
- No paint, oil, or similar liquids.
- Acceptance of items will be at the Driver's discretion.
- Large items, such as three-piece suites, washing machines, cookers, etc., can be collected by prior arrangement, for a charge. There is also a free fridge/freezer collection service, just phone 0181-401 1919.

PLEASE NOTE – THE ROUNDS HAVE CHANGED




